

Parent/Guardian Consent and Terms & Conditions for Child Participation:

- By signing this form, I, the undersigned parent/legal guardian, agree to the following terms and conditions regarding my child's participation in programs, events, volunteer activities, and initiatives organized by ImpactX Foundation:

1. Consent to Participate:

I give permission for my child to participate in activities organized, supervised, or sponsored by ImpactX Foundation.

2. Eligibility:

I confirm that my child meets any age, health, or participation requirements communicated by ImpactX Foundation.

3. Health and Medical Information:

I declare that my child is physically and mentally fit to participate in the activities. I will provide any relevant medical information, allergies, medications, or special needs that may affect participation.

4. Emergency Medical Treatment:

In the event of an emergency, I authorize ImpactX Foundation and its representatives to obtain necessary medical treatment for my child if I cannot be reached immediately. I understand that I am responsible for any resulting medical expenses.

9. Privacy and Data Protection:

I consent to the collection and storage of my child's personal information for program administration, communication, safeguarding, and legal compliance purposes. ImpactX Foundation will handle personal information in accordance with applicable privacy laws.

10. Attendance and Participation:

I understand that regular attendance and active participation may be required for certain programs and that repeated absences may affect my child's involvement.

11. Voluntary Participation:

I acknowledge that participation is voluntary and that I may withdraw my child from the program at any time by notifying ImpactX Foundation in writing.

12. Liability Release:
